

ACHIEVING VIRAL SUPPRESSION

Viral suppression is the most important clinical outcome for people with HIV. It indicates their HIV is managed as well as possible. Not only does this result in better health for the patient, it also means they are less able to transmit the virus to someone else – important for supporting overall public health.



RACIAL DISPARITIES PERCENTAGE SINCE 2014




PREVENTING NEW INFECTIONS

Pre Exposure Prophylaxis (PrEP) is the newest and one of the most effective HIV prevention tools we have to reduce new infections. It has been shown to be more than 96% effective. By providing people who may contract HIV with some of the same medications used to treat HIV, we can help reduce new infections and treat overall sexual health.



For Fiscal Year Ended August 31, 2016


