All registered voters automatically receive ballots in the mail begining March 13.

REGISTRATION DEADLINE

- Online, by mail or at the DMV: March 27
- In person at polling place: April 4

VOTING ** EARLY VOTING BEGINS MARCH 20 **

- BY MAIL: Ballots *must be received* by election officials no later than 7 PM on April 4
- AT DESIGNATED DROP BOXES (OPEN 24 HOURS/DAY): by 7 PM on April 4
- IN PERSON ON APRIL 4:
- Polls are open from 7 AM to 7 PM.
- Voters who are in line at 7 PM are still allowed to vote as long as they stay in line.
- If voting in person you will need to bring proof of residency (ex. current utility bill).

KNOW YOUR VOTING RIGHTS

- You are eligible to vote if you:
- Are a U.S. citizen
- Will be at least 18 years old on or before Election Day
- Have been a Colorado resident for at least 22 days before Election Day
- Are not currently incarcerated for a felony conviction
- For voters in jail or with convictions:
- You CAN vote while in jail awaiting trial or serving time for a misdemeanor. Contact your jail administrator to register to vote and vote by mail.
- If convicted of a felony you will automatically regain your voting rights upon release. However, you will still need to manually register to vote again.
- You CAN vote if you're on parole, even if you haven't paid all court-ordered fines and fees.
- For voters experiencing homelessness:
- You can use any physical address that you plan to return to as "where you live" when registering to vote. This can be a shelter, a park where you sleep, a vacant lot that your car is parked in, etc.
- You will be asked to give an address where your ballot will be mailed. You do not have to live at this address. For example, you can ask that your ballot be mailed to a shelter or other organization where you receive services from.
- You have 8 days to "cure" (correct) your ballot if it is rejected for a mismatched signature or other error. Use https://colorado. ballottrax.net/voter/ to track the status of your ballot.
